## PARENTAL INPUT FOR CLASSROOM TEACHERS

### I. PURPOSE

- A. The purpose of this policy is to describe the procedure for parental input for teachers.

### II. GENERAL STATEMENT OF POLICY

- A. School staff, teachers, and administrators are in the best position to determine appropriate classroom placements for all students. Classroom assignments are based upon many factors, which can include academic ability, peer relationships, gender balance, social development, out of school child care needs, and separation of family members. The finished classroom assignments reflect a balance of all those needs finalized after a considerable amount of time and effort by all individuals involved.

### III. PROCESS

- A. The school district will attempt to recognize parental input through the following policy:
  - i. Each year parents will have the opportunity to provide input on class placement.
  - ii. All parental request forms must be submitted to the school principal by the date indicated.
  - iii. Final decision regarding classroom placement will be made by the school principal and shall be binding.
